An invitation is hereby made in terms of Section 49 (1)(i) of the Act, that any property owner or other person who so desires should lodge an objection with the Municipal Manager in respect of any matter reflected in , or omitted from the supplementary valuation roll within the abovementioned period, that is on or before the 24<sup>rd</sup> May 2019.

Attention is specifically drawn to the fact that in terms of Section 50(2) of the Act, an objection must be in relation to a specific individual property and not against the valuation roll as such.
